

***Chicago Open Air Photo Hunt Challenge***  
**Official Rules**  
**NO PURCHASE OR PAYMENT OF ANY KIND IS**  
**NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES**

**General Information:** The Chicago Open Air Photo Hunt Challenge (“**Sweepstakes**”) is sponsored by Danny Wimmer Presents (“**Sponsor**”). The Sweepstakes begins July 14th, 2017 at 11:00am Central Time (“CT”) and ends July 16th, 2017 at 11:59pm CT (“**Sweepstakes Period**”).

**To Enter:** There is one (1) way to enter for a chance to win prizes in the Sweepstakes. Any attempt by any person to enter the Sweepstakes more than the permitted number of times (as described above) by using multiple/different Twitter and/or email accounts, identities, registrations and logins, or any other methods will void that person’s entries and that person may be disqualified, at the sole discretion of Sponsor. Use of any automated system to participate is prohibited and may result in disqualification.
